An Ordinance entitled an ordinance opening and extending a portion of Ninth Street in the city of Crete, Saline

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF CRETE

Section 1. That all the following described pieces or parts of lots are hereby delcared to be a portion of ninth street in said city of Crete and said Ninth street is hereby opened along and across the same, and the same is hereby delcared to be a portion of the public streets of said city of Crete for all uses and purposes whatsoever as fully, and to the same extent as though the same had been originally mapped and platted as a portion of said Ninth street to-wit: 28 feet off from the south side of lots six and seven in Block 168 and 28 feet off from the south

side of lots six and seven in Block 167 in the city of Crete, Saline county, Nebraska.

Section 2. Any and all persons claiming damages by reason of the extending of said Ninth street over along and across said lots or parts of lots shall within six months after the due publication of this ordinance file with the city clerk of said city of Crete, an application for the assessment and determination of his or her damages as provided by law.

Section 3. This ordinance shall take effect and be in full force from and after its passage, approval and publication as provided by law.
