

AN ORDINANCE OF THE CITY OF CRETE, NEBRASKA, TO CREATE PUBLIC ROADWAYS AND STREETS IN LOTHROP HEIGHTS ADDITION TO THE CITY OF CRETE, NEBRASKA, SALINE COUNTY, NEBRASKA, KNOWN AND DESIGNATED AS:

East Half of Iris Street
Locust Street
Fairchild Drive
Franklin Drive
Arthur Drive
Summit Court
St. Johns Court;

TO REPEAL ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH; AND TO PRESCRIBE THE TIME WHEN THIS ORDINANCE SHALL BE IN FULL FORCE AND EFFECT.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF CRETE, NEBRASKA:

Section 1. That there are hereby created public roadways and city streets in Lothrop Heights Addition to the City of Crete, Nebraska, Saline County, Nebraska, known and designated as:

East half of Iris Street
Locust Street
Fairchild Drive
Franklin Drive
Arthur Drive
Summit Court
St. Johns Court.

all as designated and described on the Lothrop Heights Addition Plat.

Section 2. That said roadways and city streets as set forth in Section 1 of this Ordinance shall be used and designated as city streets and roadways, and shall be known and named as set forth in Section 1 of this Ordinance, in the City of Crete, Saline County, Nebraska.

Section 3. All Ordinances and parts of Ordinances in conflict herewith are hereby repealed.

Section 4. This Ordinance shall be in full force and effect from and after its passage, approval and publication according to law.
