## SUBORDINATION AGREEMENT

This Subordination, made and executed this 5th day of August, 1974, by ROBERT E. GRIMM as Trustee,

## WITNESSETH:

WHEREAS, ROBERT E. GRIMM is Trustee under a certain

Declaration of Trust dated the 9th day of May, 1973, filed on

the 10th day of May, 1973, in Book 522, at Page 87, of the

Miscellaneous Records of Douglas County, Nebraska, between

Trinity Baptist Church of Omaha, Nebraska, a religious nonprofit

corporation organized and existing under the laws of the State

of Nebraska ("Trinity Baptist"), Trustor, which Declaration of

Trust imposed a lien upon the interests of Trinity Baptist in

and to the following described premises:

and,

WHEREAS, Trinity Baptist acquired its interests in and to the above-described property pursuant to a Land Contract dated February 5, 1973, and filed February 5, 1973, in Book 518 at Page 541 of the Miscellaneous Records of the Register of Deeds of Douglas County, Nebraska, and

WHEREAS, the entire unpaid principal balance and accrued interest in the amount of \$73,837.52 is due and owing pursuant to the terms of such Land Contract, and

WHEREAS, in order to satisfy the amount due and owing under such Land Contract it is necessary to obtain financing from the Southwest Bank in the principal amount of Sixty-five Thousand (\$65,000.00) Dollars, and it is

necessary to deliver to such Bank a subordination of the Trustee's lien as evidenced by the Declaration of Trust above identified, and

WHEREAS, the Trustee acknowledges that it is in the best interests of the Trustee and the Bondholders, for whom he is Trustee, to prevent a default by Trinity Baptist under the terms of the Land Contract, and,

WHEREAS, Trustee is required to enter into a subordination of its interests as hereinabove described,

NOW, THEREFORE, in consideration of the foregoing premises and for other good and valuable consideration, receipt of which is hereby acknowledged, the parties agree as follows:

ROBERT E. GRIMM, Trustee, does hereby subordinate and does hereby declare subordinate the lien of the Declaration of Trust above described to the lien of Southwest Bank of Omaha; such loan of the Southwest Bank, however, not to exceed the sum of Sixty-five Thousand (\$65,000) Dollars.
