and that such deed of trust was sold, transferred, and assigned to the plaintiff by written assignment recorded on November 19, 2018 as Instrument No. 2018-03295.

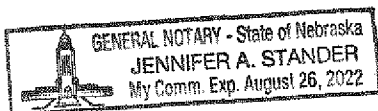
