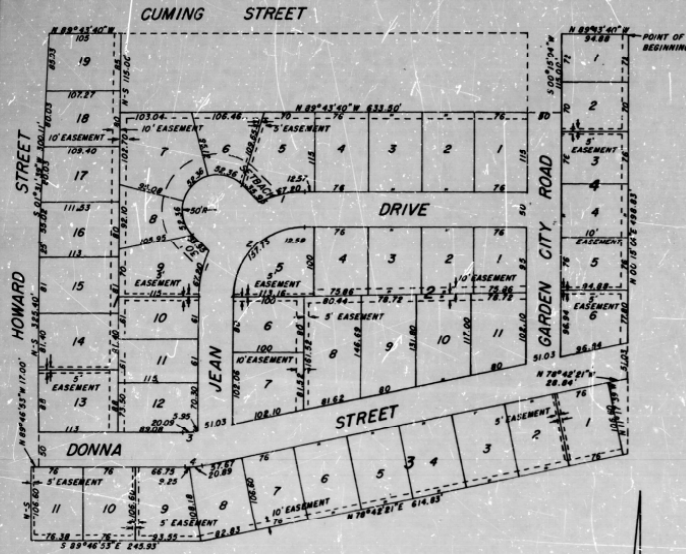

KNOW ALL MEN BY THESE PRESENTS: That Fremont Homes Inc., a Nebraska Corporation; and Edward J. Vyhlihal and Mary T. Vyhlihal husband and wife; being the record title owners of parts of lots 8, 9 and 10 Missouri Valley Land Company's Subdivision in the City of Fremont, Dodge County, Nebraska; and part of vacated Howard Street, more particularly described as follows: Beginning at the northeast corner of lot 8 and assuming the north line of lot 8 to bear N 85° 43' 40" W, thence; N 89° 43' 40" W 94.88'; thence S 00° 15' 04" W 115.00'; thence N 89° 43' 40" W 633.50'; thence S 00° 00' 00" W 115.00'; thence S 89° 43' 40" W 105.00'; thence S 1° 31' 39" W 300.11'; thence S 00° 00' 00" E 325.40'; thence N 89° 46' 53" W 17.00'; thence S 00° 00' 00" E 106.60'; thence S 89° 46' 53" E 245.93'; thence N 78° 42' 21" E 614.83'; thence N 11° 17' 39" W 106.60'; thence N 78° 42' 21" E 28.94'; thence N 00° 15' 04" E 498.83' to the point of beginning.
