1. The district shall be S.I.D. No. 146 of Sarpy County,
Nebraska, (Cedarvale Industrial Park)
2. Outer boundaries of the District (see attached)
3. The purpose for which the district is formed is for land
development of an industrial park
4. The district has the power to levy an unlimited property
tax to pay its debts and expenses of operation and maintenance.
5. The district is required to levy special assessments on
property in the district to the full extent of special benefits
arising by reason of improvements.
6. That the annual budget of the district is filed with the
County Clerk.
7. That the annual current tax levy may be obtained from the
County Clerk.
8. That a copy of the annual financial audit of the district

is on file with the clerk of the district and the Auditor of

Public Accounts.


