ORDINANCE NO. 2209

AN ORDINANCE TO ANNEX TO THE CITY OF BELLEVUE, SARPY COUNTY, NEBRASKA, CERTAIN LANDS, LOTS AND REAL ESTATE LYING WITHIN THE BELOW DESCRIBED BOUNDARIES, TO THE CITY OF BELLEVUE, SARPY COUNTY, NEBRASKA, AND DESIGNATING AN EFFECTIVE DATE.

WHEREAS, ALL OF THE LOTS, LANDS AND REAL ESTATE LYING WITHIN THE BOUNDARIES DESCRIBED AS FOLLOWS, TO WIT:

SANITARY IMPROVEMENT DISTRICT NO. 3

A parcel of ground located in the Northwest Quarter of Section 16, Township 14 North, Range 13 East of the 6th Principal Meridian, Sarpy County, Nebraska.

Beginning at the northeast corner of Lot 138 intersecting with the south side of Harrison Street. Then running west nine hundred (900) feet to the northwest corner of Lot 230. Then south five hundred (500) feet to a point intersecting Lot 222; west eight hundred and ninety (890) feet to the point on the northwest corner of Lot 207, then south along the east side of 36th Street approximately three hundred (300) feet to the southwest corner of Tax lot D8; east along the south line of Tax lot D8, eight hundred (800) feet to the east line of Tax lot D8. Then south eight hundred and ten (810) feet to the southeast corner of Tax lot D4A. Then west to the southwest corner of Tax lot D4A2 approximately eight hundred and seventy (870) feet. Then south nine hundred and ninety (990) feet to the north right-of-way line of Chandler Road; east along the north right-of-way approximately one thousand six hundred and fifty (1,650) feet to a point on the southeast corner of Lot 96; north one thousand nine hundred and thirty (1,930) feet to a point intersecting the southwest corner of Lot 129; east to the southeast corner of Lot 129. Then north six hundred and thirty (630) feet to the point of beginning.

ARE CONTIGUOUS AND ADJACENT TO THE CITY OF BELLEVUE, NEBRASKA, AND ARE URBAN OR SUBURBAN IN CHARACTER, AND

WHEREAS, SAID REAL ESTATE WILL RECEIVE MATERIAL BENEFITS AND ADVANTAGES FROM ANNEXATION TO THE SAID CITY.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF BELLEVUE, NEBRASKA:

Section 1. All of the real estate lying within the area heretofore described be and the same hereby is included within the boundaries and territory of the City of Bellevue, Nebraska, and said lands and the persons residing thereon shall hereafter be subject to all of the rules, regulations, ordinances, taxes, and all other burdens and benefits of other persons and territory

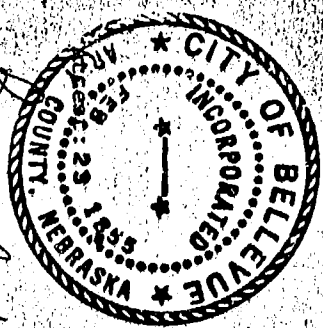
