
DISCLAIMER AND RELEASE

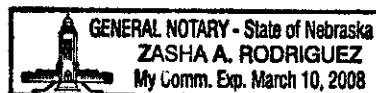


