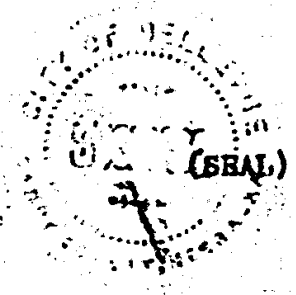

ORDINANCE NO. 572

AN ORDINANCE DECLARING THE NECESSITY, EXPEDIENCY AND PROPRIETY OF VACATING THE ALLEY IN BLOCK TWENTY-FIVE (25) IN THE CITY OF BELLEVUE, SARPY COUNTY, NEBRASKA; REPEALING ALL ORDINANCES AND ALL PARTS OF ORDINANCES IN CONFLICT HEREWITH, AND DESIGNATING EFFECTIVE DATE.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF BELLEVUE, NEBRASKA:

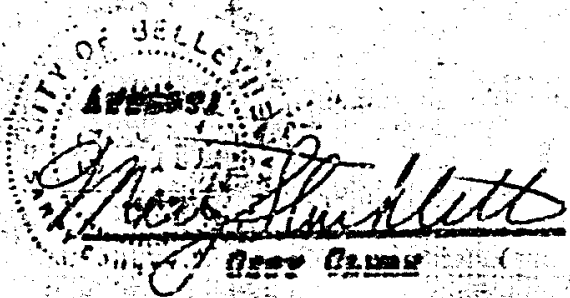
SECTION 1. IT IS HEREBY NECESSARY, EXPEDIENT AND PROPER TO VACATE THE ALLEY IN BLOCK TWENTY-FIVE (25) AND THE SAME BE AND HEREBY IS VACATED.

SECTION 2. ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH ARE HEREBY REPEALED.
