Amendment to Declaration of Condominium Ownership for the Condos on California

This Amendment to the Declaration of Condominium Ownership for the Condos on California is made on ________, 2009 by the parties listed on pages 3-14.

WHEREAS, pursuant to the terms of the Nebraska Condominium Act, Condos on California, LLC, which was the sole owner of the property legally described in Exhibit A which is attached to this document and incorporated into this document by this reference. The property described in Exhibit A is referred to in this document "Property".

WHEREAS, Exhibit B is a plat showing a new garage addition to the Property and Exhibit C is a new site plan, both of which are attached to this document and incorporated into this document by this reference.

WHEREAS, Paragraph 8 of the Declaration of Condominium for the Condos on California dated and recorded on August 11, 2006 at Document Number 2006092019 required the approval of the Board of Directors of the Condos on California Condominium Association, Inc. for any exterior improvements and

WHEREAS, such approval has been given for building a new garage to be called garage unit G12 to be treated as if it were originally part of the condominium.

WHEREAS pursuant to Paragraph 16, 67% of the votes of the Association on the basis of one vote for each unit pursuant to subparagraph 9.4 of the Declaration are required to consent to the Amendment of the Declaration either at a meeting or in writing, and the owners of this number of units have signed this Amendment to consent to this Amendment, the Declaration is amended as follows:

A. Paragraph 1, subparagraph 1.r. shall be amended to read as follows:

<u>Garage Unit(s)</u> – shall mean the garages numbered G1 through G12 located on the North side of the Parking Lot.

B. Attached to this Amendment are attachments 2 and 3, Addition to Garage G12.

- C. The land beneath garage unit G12 shall be a limited common element limited for the exclusive use of the owner of garage unit G12. The initial owner of garage unit G12 shall be the owner of unit 4 unless otherwise provided by deed.
- D. The costs of building garage unit G12 shall be paid by the owner of unit 4.
- E. Garage unit G12 shall be subject to the same provisions provided in the Declaration for units G1- G11.
- F. Garage unit G12 shall be for the exclusive use of the owner of garage unit of G12.
- G. The parties agree that the requirements of Paragraph 8 of the Declaration providing for the approval of improvements by the Board and the owners Association for making of improvements have been met with regard to garage unit G12.
- H. This Amendment is made under Paragraph 16 of the Declaration which provides for the amendment and the terms of that paragraph.
- I. This Amendment becomes effective as soon as it has been signed by 67% of the unit holders under Paragraph 9.4 which provides for one vote for each unit out of the 12 units. In other words, once the owners of 8 units have signed this amendment.






