AMENDMENT TO MASTER DEED OF CORONADO CONDOMINIUM AND AFFIDAVIT

THIS AMENDMENT TO MASTER DEED AND AFFIDAVIT (this "Amendment") is made this 16th day of May, 2016 by the undersigned owners (the "Undersigned Owners") of condominium units at Coronado Condominiums as identified on the attached signature pages.

WHEREAS, Coronado Condomíniums (the "Condomíniums"), legally described on Exhibit A attached hereto, was formed pursuant to that Master Deed (the "Master Deed"), dated June 15, 1982 and recorded June 15, 1982 at Deed Book 1687, Page 373 in the records of the Register of Deeds in Douglas County, Nebraska, which was amended by: (a) First Amendment to Master Deed dated October 7, 1983 and recorded October 12, 1983 at Misc. Book 698, Page 168; (b) Affidavit of Correction recorded October 18, 1983 at Misc. Book 698, Page 437; (c) Amendment to Master Deed and By-Laws dated April 17, 1985 recorded April 19, 1985 at Misc. Book 736, Page 428; (d) Third Amendment to the Master Deed of the Coronado Condominium Property Regime dated April 16, 1992 and recorded May 11, 1992 at Misc. Book 1011, Page 201; (e) Amendment to Easement and Master Deed dated May 14, 2001 and recorded June 22, 2001 at Misc. Book 1386, Page 549; and (f) Amendment to Master Deed of Coronado Condominium dated December 7, 2012 and recorded January 22, 2013 at Instrument No. 2013006886.

WHEREAS, the Undersigned Owners represent at least two-thirds (2/3) of the unit owners.

WHEREAS, that certain Affidavit dated February 19, 1990 and recorded February 20, 1990 in Book 0914, Page 020 (the "Affidavit") in the Register of Deeds of Douglas County, Nebraska, memorialized the assignment of the parking spaces in the indoor garage area to the Units;

WHEREAS, Section 7D of the Master Deed provides that once an assignment of a parking space is made to a particular Unit, such assignment is permanent;

WHEREAS, notwithstanding the foregoing provision of Section 7D, certain parking spaces have been transferred independently of the Unit to which such parking spaces were assigned;

WHEREAS, the Undersigned Owners desire to memorialize the current ownership of the parking spaces in relation to the Units to which they are attached;

WHEREAS, the Undersigned Owners desire to record this Amendment which change certain terms of the Master Deed and the Affidavit.

NOW, THEREFORE, it is hereby agreed as follows:

- 1. All capitalized terms used herein shall have the same meaning as ascribed to them in the Master Deed, as previously amended. Where the terms of this Amendment may conflict with the terms of the Master Deed, and prior amendments thereto, the terms of this Amendment shall control.
- 2. The provisions of Section 7D of the Master Deed regarding the permanency of assignments of parking spaces to Units is hereby waived for the sole purpose of this Amendment.
- 3. The Affidavit and, to the extent applicable, the Master Deed, are hereby amended to reflect the assignment of the parking spaces to the Units as set forth on Exhibit B attached hereto. The foregoing assignment of parking spaces to the Units shall be deemed permanent as required under Section 7D of the Master Deed and no parking space(s) shall be transferred independently of any Unit.
- 4. Except as modified herein, all other provisions of the Master Deed and the Affidavit shall remain in full force and effect.


