3-WAY JOINT

In consideration of the mutual benefits to be derived from the facilities proposed hereinafter, and the further consideration of

ONE AND NO HUNDRED DOLLARS

in hand paid, received whereof is hereby acknowledged, the undersigned, owner of LOTS 8 AND 9, BLOCK 50, BETHANY HEIGHTS

in THE SE 1/4 SEC. 16-TION-R6E OF THE 6TH P.M. in the City of Lincoln, Lancaster County, Nebraska, do hereby grant and convey to THE LINCOLN TELEPHONE AND TELEGRAPH COMPANY and to the CONSUMERS PUBLIC POWER DISTRICT, public service corporations, their successors and assigns, and to the CITY OF LINCOLN, NEBRASKA, a municipal corporation, its successors, and assigns, the right to construct, re-construct, perpetually maintain, and operate a joint electric power and telephone line, together with the necessary poles, cables, wires, crossarms, brackets, braces, underground conduits, overhangs, and anchors, etc., with the right to enter said premises for the purpose of repairing, replacing, operating, and maintaining said joint electric power and telephone line, in, over, and above the said property at about the following location:

THE E. 5' OF THE N. 83' OF SAID LOT 8, AND THE W. 5' OF THE NORTH 83' OF SAID LOT 9.

This grant shall be binding upon the heirs, executors, administrators, successors, and assigns of the grantors herein.
