FIRST AMENDMENT TO THE DECLARATION OF

COVENANTS, CONDITIONS AND RESTRICTIONS

FOR

COTTAGE ROW REPLAT,
A SUBDIVISION IN
THE CITY OF COUNCIL BLUFFS, IOWA

The undersigned, being all of the Class A members of the Cottage Row Replat Home Owners Association (there no longer being a Class B membership which ceased on January 1, 1988), do hereby unanimously amend their original Declaration of Covenants, Conditions and Restrictions which was executed on February 5, 1985 and recorded on February 15, 1985, in Book 85, Page 15718, by deleting therefrom the entire Section 12 of ARTICLE FIVE thereof and substituting in its place the following new Section 12:

ARTICLE FIVE

Section 12. Lots 1A and 1B shall be considered together in determining the propriety of obtaining a building permit for any structure thereon, and Lot 1B may be owned and built upon separately from Lot 1A only if Lot 1B contains one dwelling unit of a duplex townhome and Lot 1A contains the other dwelling unit of the duplex townhome, and likewise for Lots 2A and 2B, Lots 2C and 2D, Lots 3A and 3B, Lots 3C and 3D, Lots 4A and 4B, Lots 5A and 5B, Lots 6A and 6B, Lots 7A and 7B, Lots 8A and 8B, and Lots 9A and 9B; nothing in this paragraph shall be construed as prohibiting a single-family home upon Lots 1A and 1B joined together under common ownership (which is expressly permitted), and likewise for Lots 2A and 2B, Lots 2C and 2D, Lots 3A and 3B, Lots 3C and 3D, Lots 4A and 4B, Lots 5A and 5B, Lots 6A and 6B,


