Block 1: 5-feet on either side of common line between Lots 2 and 3; 5 and 6; 7 and 8

Block 2: 5-feet on either side of the common line between Lots 4 and 5; 8 and 9; 9 and 10; 10 and 7; 15 and 16

Block 3: 5-feet on either side of the common line between Lots 1 and 2; 8 and 9; 9 and 11; 11 and 10; 13 and 14; 13 and 15; 18 and 19; 15 and 16; 21 and 1

Block 4: The east 10-feet of Block 4; the south 5-feet of Lot 3 and the north 5-feet of Lot 4

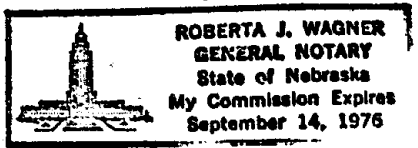
