6. On or about April 14, 2011, a document entitled "Bylaws of the Eagle Hills Homeowners' Association, Inc." was recorded with the Sarpy County Register of Deeds as Instrument No. 2011-09783 (the "Recorded Bylaws"). The Recorded Bylaws were recorded against the following property:

Lots 21 through 157, inclusive, in Eagle Hills, a subdivision, as surveyed, platted, and recorded in Sarpy County, Nebraska, together with such additional residential lots as may have been developed in Eagle Hills, a subdivision, as surveyed, platted and recorded in Sarpy County, Nebraska.

7. The Recorded Bylaws were subsequently repealed in their entirety at an annual meeting of the members of the Association on or about May 2, 2011.

8. Because the Recorded Bylaws were repealed in their entirety, the Recorded Bylaws are no longer in effect and do not govern the Association, its officers, directors, or members. Furthermore, the Recorded Bylaws are no longer in effect even though they still may be of record with the Sarpy County Register of Deeds.

9. Rather than incur the expense of recording the current version of the bylaws of the Association, the Association will make available a copy of the currently effective bylaws upon request by a member of the Association.
