The North 85 feet of the South 165 feet of the West 138 feet of Government Lot 4 (also referred to as the Southwest Quarter of the Southwest Quarter) of Section 19, Township 14 North, Range 13 East of the 6<sup>th</sup> P.M., Sarpy County, Nebraska, as shown as the hatched area on Exhibit A attached hereto and made a part hereof.
