CONTRACT. This indenture made this 2cth. day of February, 1930, by and between NEBRASKA FOWER COLLANY, a corporation, hereinalter called "The Company" and JOSELA C. ARSKA and AWILL AREKA, husband and wife, of Jarpy County, Rebraska, owners; rederal Land Dank of Omaha, Douglas County, Nebraska, Mortgagee of a certain incenture of mortgage made by said Joseph C. Kraka and Anna Kraka to said Federal Land Bank of Omana, under date of rebruary 4th, 1924, said mortgage being recorded in the records of Jarpy County, in book thirty-three (33) or mortgages at page four hundred ninety three (495); and Columbus State Bank of rlatte County, Rebraska, assignee of a certain indenture of mortgage made by said Joseph C. Krska and Anna Kroka to Howard A. Clarke under date of February 27th., 1924, said mortgage being recorded in the records of Sarpy County, in book thirty-seven (37) of mortgages at page two hundred nineteen (219), said assignment being recorded in the records of said County in book forty- ne (41) of mortgages at page four hundred eighty one (481) hereinarter called "Grantors";

WITNESCRIH: That for and in consideration of Fifteen Hundred (\$1500.00) dollars, receipt whereof is hereby acknowledged by the Grantors and mutual covenants and agreements herein contained, the Grantors do hereby grant and convey unto the Company, its lessees, successors and assigns, the perpetual right, privilege, easement, authority and right or way to construct, operate and maintain its steel towers, poles, electric transmission lines, wires, guys, unchors, and other fixtures and appliances, over, upon along and above the following described roperty situated in Sarpy County, State of Nebraska, at the points designated on the blue print hereto attached, marked Exhibit "A", and by reference made a part hereof, to wit North fifty (50) feet in width of the northeast quarter of the southeast quarter (NEI of SEI) north thirty-three (53) feet in width of the northeast quarter of the southwest quarter (NE; of SW;), all of the southeast quarter of the northwest quarter (SE; of NW;), lying south and west of Papillion Creek, all of the south half of the north east quarter (Si of the NE() lying south and west of Tapillion Creek, all of the Tax Lot two (2) lying west of new rapillion Drainage Ditch, and also south rifty (50) feet in width of Tax lot Two (2), and rax Lot One-E, (1-E), all being in section mineteen (19), Township fourteen (14) north, range thirteen (13) east of the 6th. F. ... and also Tax Lot three a (3-a, in the south east quarter of the south west quarter (3Et of 3Wt) of Section eighteen (18), Township Fourteen (14) north, range thirteen (13), east of the oth. The Grantors do hereby further grant unto the Company, its lessees, successors and a signs, the right, privilege and authority to enter upon and pass over said property and the property of the Grantor adjacent thereto for the purpose of constructing, repairing, operating and maintaining said lines and equipment under the property above described.

The Grantors do hereby further grant unto the Company, its lesses, successors and assigns the permanent right, privilege and authority to cut down or trim trues under or within enty-rive (25) feet of the Company's lines, and to cut down or trim any trees or limbs of on either side thereof as would be a hazard to said lines in reaking off and ralling over against said lines, provided, however, it is agreed between the parties hereto that owner ... all have the right to plant and maintain "hedge" trees under the Company's lines on the tract known as Tax lot three -A (3-A), said hedge, however, to be maintained by owner in such a way as not to interfers with the Company's poles, wires, etc. located on and across said tax lot three -A (3-A), and it is further agreed that ahould said hedge grow to the point of interfering with the Company's poles, wires, etc, owner shall, or company may cut nown or trim said hedge to have and maintain a minimum clearance of fifteen (15) feet under and twenty-five (25) feet to the side of the wires of Company's transmission lines.

The Company shall at all times exercise all due care and diligence to avoid any injury or damage to the crops, live-stock and other property of the Grantors and the Company agrees to indemnify and save harmless the Grantors from any and all damage and loss arising or occuring to any person or property by reason of the Company's negligence in the construction, operation and maintenance of said transmission line.
