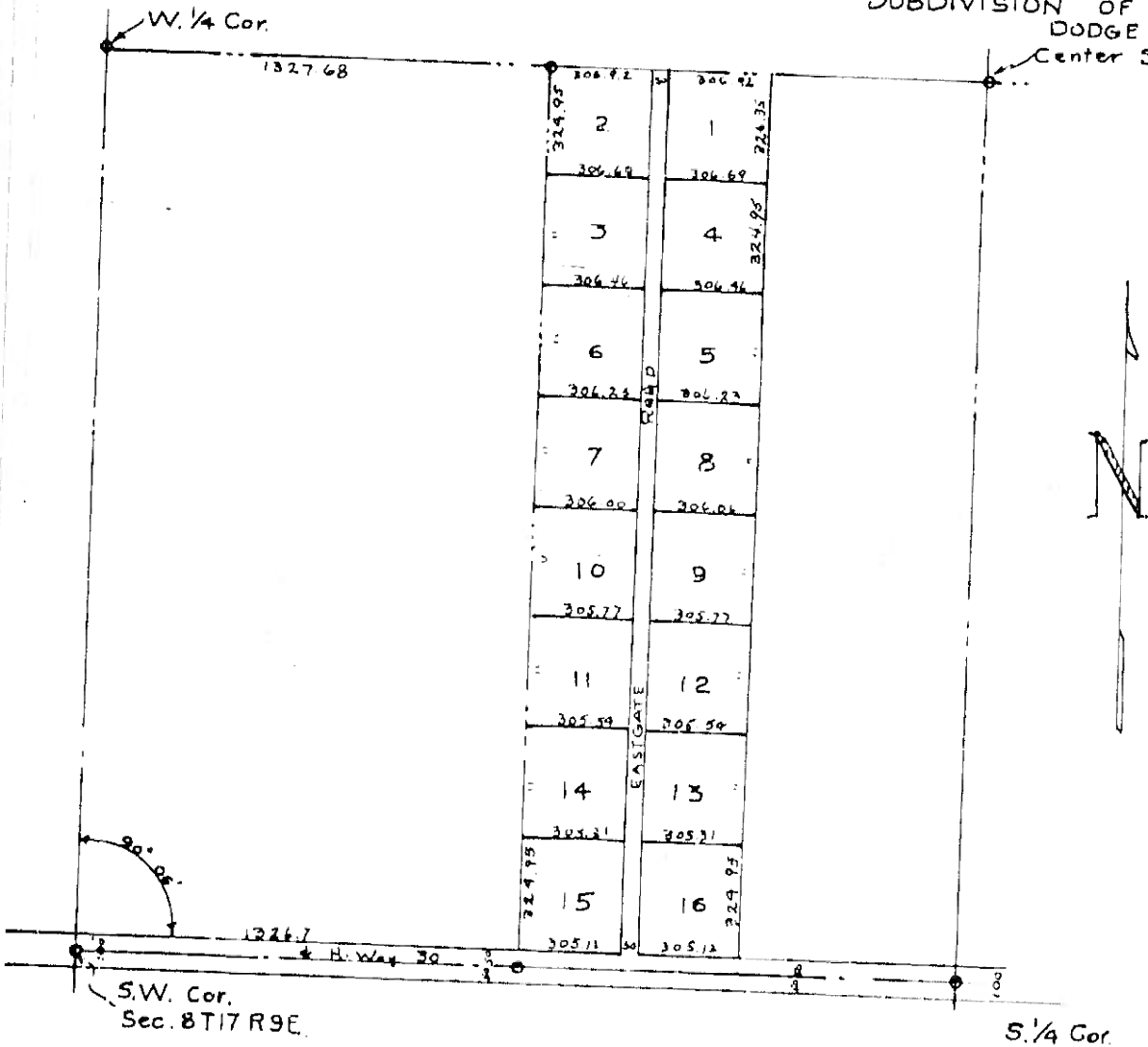

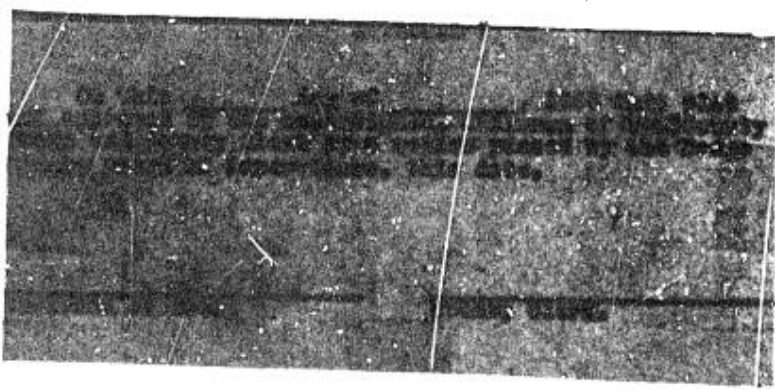
KNOW ALL MEN BY THESE PRESENTS

" DEDICATION FOR EASTGATE SUBDIVISION "

KNOW ALL MEN BY THESE PRESENTS THAT:

The undersigned, being the owners and proprietors of the land comprised in the above named and within plat in Eastgate Subdivision, being all of the West Half of the East Half of the Southwest Quarter of Section 8, in Township 17 North, Range 9 East of the 6th P.M. in Dodge County, Nebraska, being more particularly described by the metes, bounds and measurements indicated on the within plat, do hereby subdivide the said real estate as Eastgate Subdivision, and into lots and the public road running north and south as shown on the plat upon which this is written. The lots and road have the dimensions in feet indicated on the plat. There are sixteen lots numbered from 1 to 16.

The owners of the tract hereby dedicate for perpetual use of the public the road platted as shown, to be known as Eastgate Road, provided that the owners reserve from all lots and the road the right to permit the installation, operation and maintenance of telephone, electric, water and sewer utilities as required for the subdivision for improvements to be constructed on the lots. This subdivision is made with the free consent of and in accordance with the desires of the owners.
