

This is to certify that I have accurately surveyed and staked with iron PIPE, CORNERS OF ALL LOTS, BLOCKS AND ANGLE POINTS AS SHOWN ON THIS PLAT OF "FAIR LAWNS", THE SAME BEING A REPLAT OF LOTS 2,7,10 AND 15, "MAYFIELD" AN ADDITION IN DOUGLAS COUNTY, NEBRASKA, AS SURVEYED, PLATTED AND RECORDED EXCEPT THAT PART OF LOT 2, TAKEN BY THE CITY OF OMAHA, DESCRIBED
