MINERAL DEED

THIS Mineral Deed, dated as of the 29th day of September, 1992, between UPLAND INDUSTRIES CORPORATION, a corporation of the State of Nebraska, Grantor, and UNION PACIFIC LAND RESOURCES CORPORATION, a corporation of the State of Nebraska, with its principal place of business at P.O. Box 7, Mail Station 3110, Fort Worth, Texas 76102-6803 (successor by merger to Union Pacific Land Resources Corporation, a Utah corporation), Grantee:

WITNESSETH, That Grantor does hereby quitclaim as a contribution, without consideration, to the capital of Grantee, and by these presents does REMISE, RELEASE AND QUITCLAIM unto Grantee, its successors and assigns, forever, all of its right, title, interest, estate, claim and demand, both at law and in equity, in and to all minerals and all mineral rights of every kind and character now known to exist or hereafter discovered in and underlying the property situate in the County of Douglas, State of Nebraska, as more particularly described in Exhibits 1 through 13, including, without limiting the generality of the foregoing, oil and gas and rights thereto, together with the sole, exclusive and perpetual right to explore for, remove and dispose of, said minerals by any means or methods suitable to Grantee, its successors and assigns, but without entering upon or using the surface of said lands, and in such manner as not to damage the surface of said lands or to interfere with the use thereof by Grantor, its successors and assigns.

TOGETHER with all and singular the appurtenances thereunto belonging; TO HAVE AND TO HOLD the said UNION PACIFIC LAND RESOURCES CORPORATION, and unto its successors and assigns, forever.

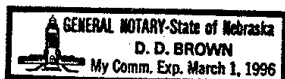

thence northwesterly along a curve to the left, having a radius of 939.72 feet and which is tangent at its point of beginning to said center line of present main lead track, a distance of 913.55 feet;

thence northwesterly along a straight line tangent to the end of the last described curve a distance of 618.27 feet;

thence northwesterly along a tangent curve to the right having a radius of 939.72 feet a distance of 912.77 feet, more or less, to a point in the center line of said existing main lead track.

Excepting therefrom all that portion thereof in said Block "G" lying westerly of a straight line parallel with and 8.5 feet distant easterly, measured at right angles, from the center line of the tangent portion of said main lead track as now constructed and operated.

Containing a net area of 1.37 acres, more or less.

No. 24838;

thence North 55 degrees 35 minutes 15 seconds West, a distance of 132.21 feet to the beginning of a tangent curve concave northeasterly having a radius of 924.72 feet;

thence northwesterly along said curve through a central angle of 3 degrees 06 minutes 04 seconds, an arc distance of 50.05 feet to a point on the west line of said Block H;

thence along said west line of Block H, South 0 degrees 08 minutes 41 seconds West, a distance of 104.17 feet to the Point of Beginning.

EXCEPTING THEREFROM that portion lying within the 30.0 foot wide strip of land described above.

Containing a gross area of 1.44 acres, more or less.
