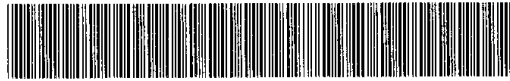

DRIVEWAY EASEMENT

KNOW ALL MEN BY THESE PRESENTS, that the undersigned, SCOTT A. ISAACSON, ~~a single person~~³⁰, who is the owner of Lot 2, The Gosch Estate a subdivision in Douglas County, Nebraska, ("Grantor"), for and in consideration of the payment of the sum of One Dollar (\$1.00) and other good and valuable consideration in hand paid, receipt and sufficiency of which is hereby acknowledged, does hereby grant, transfer and convey to Scott A. Isaacson, the owner of Lot 1, The Gosch Estate, a subdivision, in Douglas County, Nebraska, and such owner's successors, grantees, heirs and assigns ("Grantee"), a permanent nonexclusive ingress and egress easement over and upon the real property described in Exhibit "A" attached hereto and by reference made a part hereof ("the Easement Area") for the purpose of permitting the Grantee to maintain and repair a hard surfaced driveway to obtain ingress and egress from the Lot 1, The Gosch Estate, a subdivision in Douglas County, Nebraska to 132nd Street. The Grantee shall perform all usual and necessary maintenance of the driveway.

This easement shall run with the land of the Grantor and the Grantee, and extend to and be binding upon the Grantor and Grantee, and to their respective successors, heirs, grantees and assigns, and shall be enforceable at law or equity. Grantor hereby represents and warrants that it is the owner of the Easement Area, and that it has the full right and authority to make, execute and deliver this easement in the form and substance set forth herein.

IN WITNESS WHEREOF, the Grantor executed this Easement this 28th day of January, 2005.

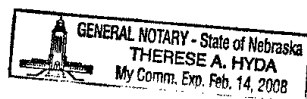

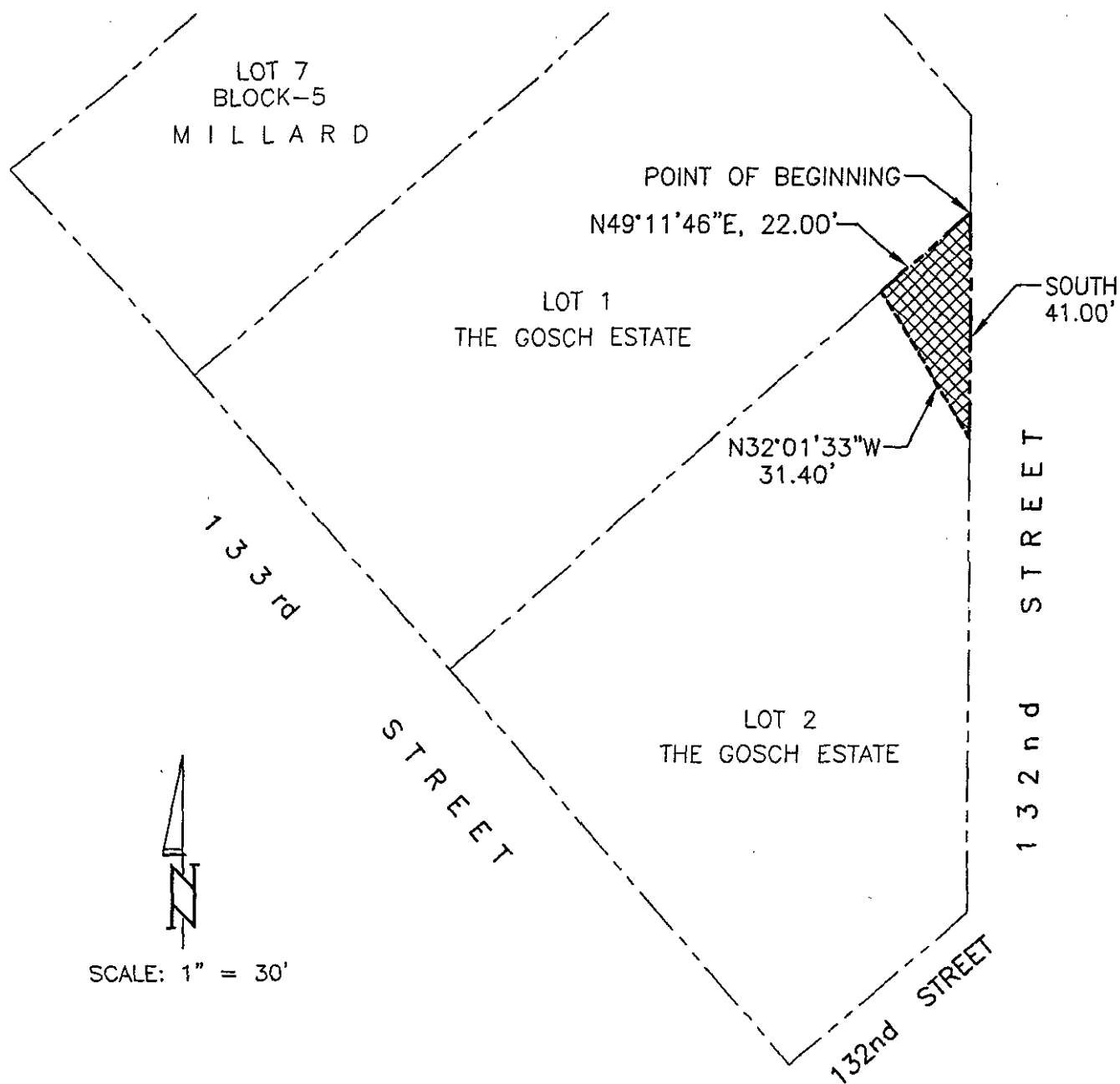
