One drive, unrestricted as to use, not to exceed
60 feet in width, the centerline of which is located on the
South Line of the North Half of the Southeast Quarter of
Section 15, Township 14 North, Range 12 East of the 6th P.M.,
Sarpy County, Nebraska, the above driveway voids and supersedes
a driveway previously granted by Condemnation proceedings,
filed for record in Sarpy County, Nebraska, on December 14,
1962 and recorded in Book 31, Miscellaneous records, page
34, said driveway being located 117.9 feet southerly from the
North Line of said North Half of the Southeast Quarter as
measured along the centerline of the highway.

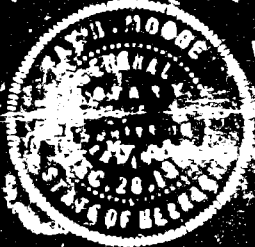
