AN ORDINANCE TO ANNEX CERTAIN REAL ESTATE TO THE CITY OF LA VISTA, NEBRASKA;
TO MAKE PROVISION FOR EXTENSION OF BENEFITS TO INHABITANTS OF THE TERRITORY
ANNEXED; TO PROVIDE THE EFFECTIVE DATE HEREOF.

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF LA VISTA,
SARPY COUNTY, NEBRASKA.

Section 1. The following described real estate situated in Sarpy
County, Nebraska, to wit:

The entire road right of way of 72nd Street beginning at the
intersection of 72nd Street and Valley Road south to the
centerline of Giles Road;

The entire road right of way of 84th Street (Highway N-85)
from existing city limits (east quarter corner of Section
15, Township 14 North, Range 12 East of the 6th P. M.)
south to the centerline of Giles Road;

A strip of land described as the West Fifty (50) feet of
the Southeast Quarter of Section 15, Township 14 North,
Range 12 East of the 6th P. M.;

The South Fifty (50) feet of Sections 15 and 14, Township
14 North, Range 12 East of the 6th P. M., and also the
South Fifty (50) feet of the Southwest Quarter of Section
13, Township 14 North, Range 12 East of the 6th P. M.,
including county road right of way situated therein,

be, and the same hereby is, included within the corporate limits of the
City of LaVista, Sarpy County, Nebraska; and that the inhabitants thereof
shall, from and after the effective date of this ordinance, be subject to
the ordinances and regulations of the City of LaVista, Sarpy County,
Nebraska.

Section 2. That the City Council of the City of LaVista shall, within
one year from date hereof, make adequate plans and take such action as shall
be necessary to provide the inhabitants of the area annexed hereby with
substantially the benefits of other inhabitants of the City of LaVista, as
required by Section 17-405.04, R.R.S. Nebr. 1943.

Section 3. This ordinance shall take effect and be in force from and
after its passage, approval and publication as provided by law.
