## NOTICE OF CONTINUING ASSESSMENT LIEN

TO WHOM IT MAY CONCERN:

Glenbrook Homes Association, a Nebraska nonprofit corporation (the "Association"), is responsible for and effects the maintenance of the common areas in Glenbrook Subdivision in Douglas County, Nebraska, ("Glenbrook"), in accordance with the Second Amended Declaration of Glenbrook recorded in the Office of the Register of Deeds for Douglas County, Nebraska, and found at Miscellaneous Book 581, Pages 89-96, inclusive, (the "Declaration").

Pursuant to Article V, Section I of the Declaration, the Association has the authority to levy assessments which shall become liens against all property located in Glenbrook, more particularly described as follows:

Lots Five (5) through One Hundred Six (106), and One Hundred Nine (109) through One Hundred Fifty-Seven (157), inclusive, and Lots A through E, inclusive, in Glenbrook, a subdivision, as surveyed, platted and recorded in Douglas County, Nebraska.

Article V, Section I of the Declaration provides that each owner of any lot in Glenbrook, by acceptance of a deed therefore, whether or not it shall be so expressed in such deed, is deemed to covenant and agree to pay to the Association (1) annual assessments or charges, and (2) special assessments for capital improvements, such assessments to be established and collected as provided for in the Declaration. The annual and special assessments, together with interest, costs, and reasonable attorneys' fees shall be a charge on the land and shall be a continuing lien upon the property against which each such assessment is made. All subsequent purchasers shall take title subject to said lien and shall be bound to inquire of the Association as to the amount of any unpaid assessments. Each such assessment, together with interest, costs, and reasonable attorneys' fees, shall also be the personal obligation of the person who was the owner of such property at the time when the assessment fell due. The personal obligation for delinquent assessments shall not pass to a successor in title unless expressly assumed by the successor.
