
**RATIFICATION OF DEDICATION**



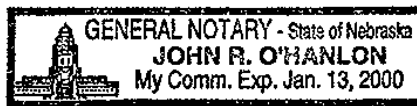

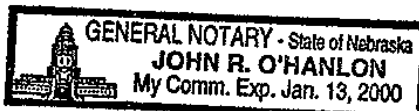
