EASEMENT AND RIGHT OF WAY

THIS INDENTURE, made this 77th day of _________, 1974, between Dodge Investments, Ltd., a Nebraska limited partnership, hereinafter referred to as "Grantor", and Metropolitan Utilities District of Omaha, a municipal corporation, hereinafter referred to as "Grantee", WITNESSETH:

That the Grantor, in consideration of the sum of One Dollar (\$1.00) and other valuable consideration, receipt of which is hereby acknowledged, does hereby grant to Metropolitan Utilities District of Omaha, its successors and assigns, an easement and right of way to lay, maintain, operate, repair, relay and remove, at any time, pipelines for the transmission of gas, and all appurtenances thereto, together with the right of ingress and egress to and from the same, on, over, and through lands described as follows:

Several strips of land lying in Lots 51, 52, 53, 54, 55, 56, 57, 58, 59, 60, 61, 62, 63, 75, 76, 77, 78, 79, 80, 81, 82, 83, 84, 85, 86, 87, and 88 of Glenbrook Addition as now platted and recorded, a subdivision in Douglas County, Nebraska, said strips being more particularly described as follows:

A continuous strip of land Five (5) feet wide lying in Lots Fiftyone (51), Fifty-two (52), Fifty-three (53), Fifty-four (54), Fifty-five (55), Fifty-six (56), Fifty-seven (57), Fifty-eight (58), Fifty-nine (59), Sixty (60), Sixty-one (61), Sixty-two (62), and Sixty-three (63), said strip running along and parallel to Girard Plaza and extending from the Easterly property line of Lot Fifty-one (51) to the Easterly property line of Lot Sixty-three (63): three (63);

A continuous strip of land Five (5) feet wide lying in Lots Seventy-five (75), Seventy-six (76), Seventy-seven (77), Seventy-eight (78), Seventy-nine (79), Eighty (80), Eighty-one (81), Eighty-two (82), and Eighty-three (83), said strip running along and parallel to Weber Plaza and extending from the Easterly property line of Lot Seventy-five (75) to the Northerly property line of Lot Fighty-three (83): line of Lot Eighty-three (83);

A continuous strip of land Five (5) feet wide lying in Lots Eighty-four (84), Eighty-five (85), Eighty-six (86), Eighty-seven (87), and Eighty-eight (88), said strip running along and parallel to Weber Plaza and extending from the Southerly property line of Lot Eighty-four (84) to the Easterly property line of Lot Eightyeight (88);

All of these strips containing a total of Fourteen One-hundredths (0.14) acre, more or less, all as shown on the plat attached hereto and made a part hereof.

TO HAVE AND TO HOLD said easement and right of way unto the said Grantee, Metropolitan Utilities District of Omaha, its successors and assigns.

- 1. Grantor, its successors or assigns agree that they will at no time place any building or structure, except pavement, over the said pipelines as they may be located and that they will not permit anyone else to do so.
- 2. Grantee agrees, for itself, its successors and assigns, that the installation of pipelines under authority of this easement and right of way is and will be for the purpose of furnishing gas service to the above described area and for no other purpose.
- 3. Grantee shall restore the surface of the soil excavated for any purpose hereunder, as near as may be reasonably possible, to the original contour thereof and as soon after such work is performed as may be reasonably possible to do so.

4. Nothing herein contained shall be construed as a waiver of any rights of Grantor, or duties and powers of Grantee respecting the owner ship, use, operations, extensions and connections to any gas service constructed and maintained hereunder.

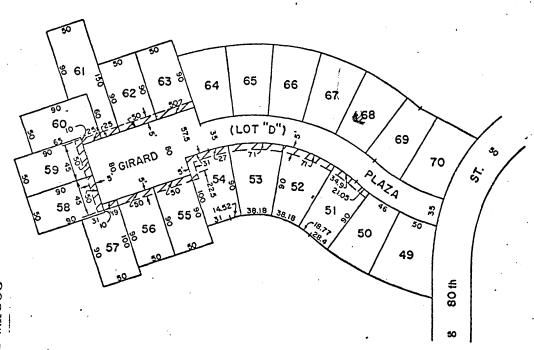
