CORRECTION DEED OF EASEMENT

Easement made this 17th day of June, 1978, between GOTTSCH FEEDING CORPORATION, a Nebraska corporation, Grantor, and ALLAN F. SORENSON, Grantee.

WITNESSETH that whereas, Grantor and Grantee are the owners of adjacent tracts of real estate in Arlington, Washington County, Nebraska;

NOW, THEREFORE, and for a valuable consideration, Grantor does hereby convey unto Grantee a perpetual, but nonexclusive easement across and over the following described real estate:

The South 5 feet of Lot 8, Block C and Lot 8, Block B in Gottsch's Addition to the Village or Arlington, as platted and recorded in Washington County, Nebraska.

The purpose of this easement is to permit the Grantee to install, maintain and repair a natural gas pipeline below the surface of the above-described real estate.

This correction deed of easement given to correct an earlier deed of easement between the parties, in which ALLAN F. SORENSON was incorrectly designated as JOHN SORENSON, the same being his nickname, and ALLAN F. SORENSON and JOHN SORENSON, being one and the same person, and further to correct and properly show ROBERT GOTTSCH as President of GOTTSCH FEEDING CORPORATION, Bob Gottsch again being a nickname and ROBERT GOTTSCH and BOB GOTTSCH being one and the same person.
