PIPELINE INSTALLATION AGREEMENT

WITNESSETH: .

That Gulf Central Pipeline Company and the County of Washington,

State of Nebraska, hereinafter referred to as "Washington" do hereby

enter into the following agreement:

WHEREAS, Washington is the owner and responsible for certain public roads in the County of Washington, State of Nebraska, and Gulf Central Pipeline Company is a corporation created for the purpose of transporting petroleum gases or other products thereof including anhydrous ammonia in interstate commerce which desires to cross certain public roads located within said County; and,

WHEREAS, pursuant to the provisions contained in par. 57-1102 R.R.S. Neb. Washington is willing that a six-inch steel pipeline cross said County roads by Gulf Central Pipeline Company, and gas, oil, petroleum and petroleum products (including, but not limited to, anhydrous ammonia) or derivatives, or other liquids, gases or substances which can be transported through pipelines be carried across said roads located within said County, subject, however, to reasonable regulations and restrictions.

NOW THEREFORE, in consideration of payment of One Dollar and other valuable consideration, Washington does hereby grant a license or permit to Gulf Central Pipeline Company to lay, install, and construct said pipeline under the public roads in Washington County, Nebraska, as shown on drawing no. GCD-68S-172 subject to the following terms and conditions:

1. The installation and construction of said pipeline shall meet the written specifications required by the County Highway Commissioner or the County Engineer and shall be of sufficient depth or strength so that the roadway will not be liable to cave in. Further, the pipeline shall be appropriately packed and installed in a workmanlike manner so that the surface of that road, from a strength and levelness standpoint, shall be the same as if there were no pipeline in the roadway.

- 2. The future maintenance of said pipeline and reinstallation or reconstruction of same for any purpose whatsoever shall be borne by Gulf Central Pipeline Company.
- 3. Further, Gulf Central Pipeline Company does by these presence in return for the license herein granted, stipulate and agree to indemnify and hold forever harmless said Washington or any of its officers, agents or employees by reason of the installation, construction and maintenance of said pipeline, together with pipe or any other items used in connection therewith.
