C O N T R A C T

This indenture made this 19th day of February, 1949, by and between OMAHA PUBLIC POWER DISTRICT, a quasi public corporation hereinafter called "The District" and Henry Hauschild & Orpha Hauschild, Husband & Wife of the County of Sarpy, State of Nebraska, hereinafter called "Grantor (s)":

WITNESSETH: That for and in consideration of \$45.00, receipt whereof is hereby acknowledged by Grantor (s), and mutual covenants, and agreements herein contained, the Grantor (s) do (es) hereby grant and convey unto the District, its successors and assigns, the perpetual right, privilege, easement, authority and right of way to construct, operate, and maintain its poles, electric transmission lines, wires, guys and other fixtures and appliances, over, upon, along and above the following described property situated in Sarpy County, State of Nebraska, to-wit:

Tax Lot "11A" in the Southwest Quarter (SW $\frac{1}{4}$) of Section 22 Township 14 North Range 13 East of the 6th P.M.

Said transmission line to be of single pole construction and to be located along the South line of said Section 22.

The Grantor (s) do (es) hereby further grant unto the District, its successors and assigns, the right, privilege and authority to enter upon and pass over said property and the property of the Grantor (s) adjacent thereto for the purpose of constructing, repairing, operating and maintaining said lines and equipment upon the property above described.

The Grantor (s) do (es) hereby further grant unto the District, its successors and assigns, the permanent right, privilege and authority to cut down trees under or within six (6) feet of the the District's lines, and to cut down or trim any trees or limbs of trees on either side thereof as would be a hazard to said lines in breaking off and falling over or against said lines. All refuse or debris from such tree cutting and trimming shall be disposed of by _____

The District shall at all times exercise all due care and diligence to avoid any injury or damage to the crops, live stock and other personal property of the Grantor (s) and the District agrees to indemnify and save harmless the Grantor (s) from any and all such damage and loss arising or occurring to such property solely by reason of the District's negligence in the construction, operation and maintenance of said electric line.
