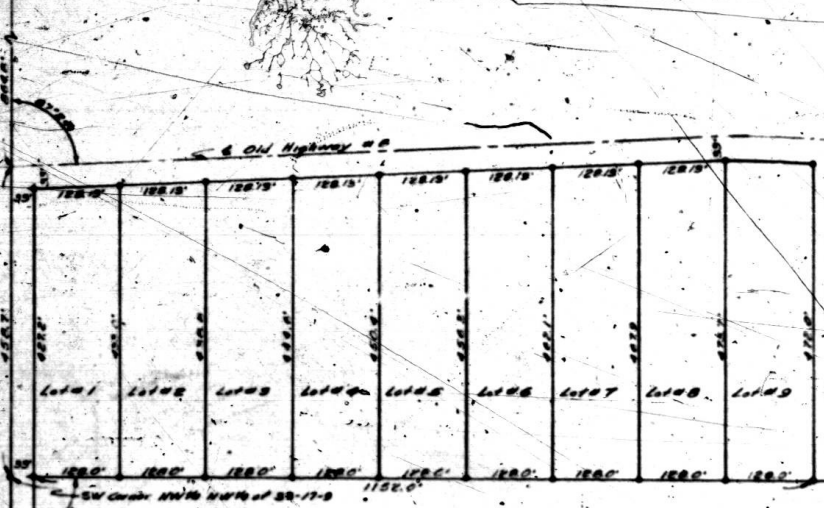


Green Meadows Sub-division

DEDICATION

Know all men by these presents that Guy E. and Margaret's Refused, being the record title owners of that part of the West Half of the Northwest Quarter of Section 25, Township 35 North, Range 1 East of the 9th, and described as follows: Commencing at the Northwest Corner of the Northwest Quarter of the Northwest Quarter of said Section 25; Thence East of 128.0' to the West corner of said Northwest Quarter of the Northwest Quarter of said Section 25; thence South of 128.0' to the point of beginning; thence continuing East to the above described corner the distance of 128.0'; thence South of said point of beginning parallel to the West corner of said Northwest Quarter of the Northwest Quarter of the Northwest Quarter of said Section 25 a distance of 1152.0' to a point on the South Right-of-Way of the Highway of the State of Iowa; thence South along said South Right-of-Way of the Highway of the State of Iowa to the West corner of said Northwest Quarter of the Northwest Quarter of the Northwest Quarter of said Section 25; thence East a distance of 128.0' to the point of beginning; all being more particularly shown on a certain plat of land heretofore filed for record in the office of the State Register of Deeds and the office of the State Surveyor for the State of Iowa, under the name of 'Green Meadows Sub-division' and recorded in the office of the State Register of Deeds and the office of the State Surveyor for the State of Iowa.
