- 5. The District is required to levy special assessments on property in the District to the full extent of special benefits arising by reason of improvements installed by the District.
- 6. That the annual budget of the District is filed with the County Clerk, which budget shows the anticipated revenue and expenses, tax levy, and indebtedness of the District.
- 7. That the actual current tax levy amount of the District may be obtained from the County Clerk.
- 8. That a copy of the annual financial audit of the District is on file with the Clerk of the District and the Auditor of Public Accounts.
