AMENDMENT TO DECLARATION OF COVENANTS, CONDITIONS, RESTRICTIONS AND EASEMENTS OF HANOVER FALLS

This Amendment to Declaration of Covenants, Conditions, Restrictions and Easements of Hanover Falls (this "Amendment") is entered into by Hearthstone Homes, Inc., a Nebraska corporation ("Hearthstone").

WHEREAS, Military Holdings, LLC, a Nebraska limited liability company ("Military Holdings"), was the original Declarant under that certain Declaration of Covenants, Conditions, Restrictions and Easements of Hanover Falls which was recorded in the office of the Douglas County Register of Deeds on October 16, 2006 as Instrument Number 2006119008 (the "Declaration"), which Declaration was filed against the following described real property, to-wit:

Lots 1 thru 113, inclusive, Lots 115 thru 122, inclusive, and Outlots "A" thru "C", inclusive, Hanover Falls, as surveyed, platted and recorded in Douglas County, Nebraska.

WHEREAS, Military Holdings assigned its rights as Declarant to Hearthstone, and Hearthstone expressly assumed such rights, pursuant to that certain Revocable Assignment and Assumption of Declarant Rights and Notice dated as of October 12, 2006 and recorded with the Douglas County Register of Deeds on October 16, 2006 as Instrument No. 2006119009 (the "Assignment").

WHEREAS, Article IV, Paragraph 2 of the Declaration provides that the Declaration may be amended by the Declarant, or any person, firm, corporation, partnership, or entity designated in writing by the Declarant, in any manner which it may determine in its full and absolute discretion for a period of ten (10) years following October 11, 2006.

NOW, THEREFORE, Hearthstone, as the Declarant, hereby declares as follows:

- 1. <u>Amendment</u>. The Declaration is hereby amended as follows:
 - a. The second sentence of Paragraph 8 of Article I shall be deleted in its entirety and shall be replaced with the following:

"Fences constructed adjacent to 156th Street and Bondesson Street Outlots "A" and "C", inclusive, Hanover Falls (Lots 1 thru 12, inclusive; and, Lot 70, Hanover Falls) must be a six

- (6) foot high privacy type with pickets, which fence must meet the specifications set forth on Exhibit "A-1" attached hereto and incorporated herein by reference, or equivalent."
- b. Exhibit "A-1" shall be deleted in its entirety and shall be replaced with Exhibit "A-1" attached hereto.
- 2. <u>No Other Amendments</u>. Except as set forth herein, all of the other terms and conditions of the Declaration shall remain the same and in full force and effect.


