KNOW ALL MEN BY THESE PRESENTS:

1. That on January 27, 1975, Schuemann Burgett Dev. Co., grantors, of Pottawattamie County, granted to Iowa Power and Light Company, its successors and assigns, the perpetual right and easement to install an underground electric supply line over and across the following described real estate:

Easement to consist of and be limited to a tract of ground 10 feet in width, to be utilized as electrical service for the Oakland Savings Bank and to be located on Lot 6 in Plat of Schuemann Burgett 2nd Addition to Oakland, Pottawattamie County, Iowa.

2. That said easement is recorded in Book 75, Page 1244, in the Office of the Recorder in and for Pottawattamie County, Iowa.

3. That Iowa Power and Light Company hereby limits the above described easement to a strip of land 10 feet in width to be described as follows:

The south 10 feet of the east 185 feet of Lot 6, Schuemann Burgett 2nd Addition to the City of Oakland, Pottawattamie County, Iowa.

4. This easement in no way affects, limits or changes any of the provisions, conditions, or grants of rights contained in the original electric supply line easement as described in Paragraph 1 above, except as specifically amended in accordance with Paragraph 3 above.
