PAPIO NATURAL RESOURCES DISTRICT Partial Release of Masement

RECITALS:

- 1. By an easement ("the Easement") dated October 29, 1980 and recorded on November 3, 1980 in Book 53 and 715 of the Records of the Register of Deeds of Sarpy County, Nebraska, Chris G. Otte, single, as Grantor, granted to the Papio Natural Resources District, as Grantee, a permanent easement over and across the following described land, ("the Easement Area"), to-wit: The East Half (E-1/2) of the Northeast Quarter (N 1/4) of Section Sixteen (16), Township Fourteen (14) North, Range Eleven (11) East of the 5th p.m., Sarpy County, Nebraska for purposes of construction, operation, maintenance and inspection of a grade stabilization structure.
- 2. Pursuant to the terms of the Easement, the Grantee has determined that easement rights over certain portions of such Easement Area will be permanently necessary for the purposes of such project and that the Easement rights and privileges should be permanently retained over such lands for such purposes, and that the remainder of such lands not thus retained and reserved should be released from the Easement.

THEREFORE, in consideration of the covenants of the Easement, and in compliance therewith, the Grantee Papio Natural Resources District does hereby permanently retain and reserve all rights and privileges granted by the Easement over the following lands described and shown on the diagram marked Exhibit "A" affixed hereto, and incorporated herein by reference, which reserved lands the Grantee District has determined are necessary for the operation, inspection, and maintenance of the project structure and appurtenances thereto, for permanent and flood pools, for flowage and release of waters, and for ingress and egress. Correspondingly, the Grantee Papio Natural Resources District does hereby forever release, relinquish and quitclaim unto the Grantor and the Grantor's heirs, successors and assigns all the remaining parts and portions of the original Easement Area not thus permanently retained and reserved.
