The following Protective and Restrictive Covenants are created, adopted, and established for all the lots and blocks in Herbert Brothers' Indian Hills Third Addition Replat to Lincoln, Lancaster County Nebraska:

- 1. No building shall be erected, altered, placed or permitted to remain on any let other than:
 - (a) one detached single family dwelling, which shall in no case exceed 3 stories, or 35 feet in height, and

(b) a private garage for not more than three cars for each dwelling, 1000 square feet or four stalls for a deta ched building.

- 2. The ground floor area of the main structure, exclusive of one story openporches and garages shall be no less than 1000 square feet for a one story dwelling, nor less than 800 square feet for a dwelling of more than one story.
- 3. No building shall be located on any lot mearer than 30 feet to the front lot line. No building shall be located nearer than 10 feet to any side lot line, except that a garage or other permitted accessory building located 60 feet or more from the front let line may be located not nearer than 2 feet from any such side lot line. For the purpose of this covenant, eaves, steps and open purches shall not be considered as a part of a building: provided, however, that this shall not be constued to permit any portion of a building on a lot that may encroach on another lot.
- 4. No lot shall be re-subdivided into, nor shall any dwelling be placed on any lot having a width of less than 60 feet at building set back line, or an area of less than 9000 square feet.
- 5. Five (5) feet easements for the manu construction and maintenance of sewers, conduits, and lines are reserved as provided in the recorded Plat and Dedication.
- 6. No noxious or offensive activity shall be carried on upon any lot, nor shall anything be done thereon which may be or become an annoyance or nuisance to the neighborhood.
- 7. No animals, livestock or poultry of any kind shall be raised, bred or kept on any lot, except that dogs, cats of other household pets may be kept; provided that they are not kept, bred or maintained for any commercial purpose.
- 8. These covenants are to run with the land and shall be binding on all parties and all persons claiming under tham for a period of 25 years from the date these covenants are recorded, after which time said covenants shall automatically renewed for successive periods of 10 years unless an instrument signed by a majority of the then owners of the lots has been recorded agreeing to change said socenants in whole of in part.
- 9. Enforcement shall be by proceedings at any or in equity against any person or persons violating of attempting to violate any covenants either to retarinviolation or to recover damages.

- 11. No building shall be erected of less than 25% brick, stone or Founders Concrete brick veneer.
- 12. No outside television antenna shall be erected after the availability of cable television service.
