AGREEMENT

THIS AGREEMENT made and entered into this _____ day of
Carl S. Hillel
June, 1985, by and between SANITARY AND IMPROVEMENT DISTRICT No.
REGISTRY OF DEEDS
40 of Sarpy County, Nebraska, hereinafter called "SID #40", and
SANITARY AND IMPROVEMENT DISTRICT No. 132 of Sarpy County,
Nebraska, hereinafter called "SID #132",

WITNESSETH:

This this Agreement is made pursuant to the authority of
Section 31-770, Revised Statutes of Nebraska, 1943, as amended
(1972 Cumulative Supplement).

The parties jointly declare that the Board of Trustees
of both SID #40 and SID #132 have received requests from owners
of land which is a part of both districts and that such owners
desire that such land be a part of only one District.

The parties jointly declare and agree that the following
described real estate is now a part of both SID #40 and SID #132,
to-wit:

That part of the Southwest Quarter of Section 17, Township 14
North, Range 13 East of the 6th P.M., Sarpy County, Nebraska
described as follows: Commencing at the northwest corner of
said Southwest Quarter; thence East on the North line of
said Southwest Quarter 33.00 feet to the point of beginning;
thence South on a line 33.00 feet East of and parallel to the
West line of said Southwest Quarter, 660.00 feet; to a point
on the South line of Tax Lot 4 in said Southwest Quarter;
thence East on the South line of said Tax Lot 4, 627.00 feet
to the southeast corner of said Tax Lot 4; thence North on the
East line of said Tax Lot 4, 660.00 feet to a point on the
north line of said Southwest Quarter; thence West on the
North line of said Southwest Quarter, 627.00 feet to the point
of beginning.

The parties jointly declare and agree that it is in the
best interests of both the districts that an agreement be deve-
loped and entered into providing for the detachment of the land
above described from SID #40 and for the adjustment of the indeb-
tedness attributable thereto.

NOW, THEREFORE, it is agreed by and between Sanitary and
Improvement District Nos. 40 and 132 as follows:

Rec'd 15283

1. The land herein described shall upon execution of this Agreement be detached from Sanitary and Improvement District No. 40 and shall be and remain a part of Sanitary and Improvement District No. 132, and shall be subject to all lawful obligations of Sanitary and Improvement District No. 132.

2. That upon execution of this Agreement and the payment of the sums by Sanitary and Improvement District No. 132 to Sanitary and Improvement District No. 40 as hereinafter set forth, said land shall be released of all obligations including tax levies of Sanitary and Improvement District No. 40.

3. Sanitary and Improvement District No. 132 shall, at the time of the execution of this Agreement, deliver to Sanitary and Improvement District No. 40 a warrant drawn upon the construction fund of Sanitary and Improvement District No. 132 and payable to Sanitary and Improvement District No. 40 in the sum of \$7,500.00.

4. Sanitary and Improvement District No. 40 and Sanitary and Improvement District No. 132 agree that the execution of this Agreement has been duly authorized by Resolutions of their respective Boards of Trustees adopted at public meetings after public notice as required by law, copies of which Resolutions are attached hereto and made a part of this Agreement.

IN WITNESS WHEREOF, Sanitary and Improvement District No. 40 and Sanitary and Improvement District No. 132 have caused these presents to be executed by the Chairman and Clerk of the Board of Trustees of both Districts, the date and year first above written.
