## AMENDMENT TO COVENANTS

## **DECLARATION OF RESTRICTIONS**

WHEREAS, ROBERT M. SCHAEFER AND BEVERLY A. NOW, THEREFORE, THE OWNERS HEREBY DECLARE THAT ALL OF THE PROPERTY DESCRIBED ABOVE IS HELD AND SHALL BE HELD, CONVEYED, HYPOTHECATED OR ENCUMBERED, LEASED, RENTED, USED, OCCUPIED, AND IMPROVED SUBJECT TO THE FOLLOWING LIMITATIONS, RESTRICTIONS, CONDITIONS, AND COVENANTS, ALL OF WHICH ARE DECLARED AND AGREED TO BE IN FURTHERANCE OF A PLAN FOR THE SUBDIVISION, IMPROVEMENT, AND SALE OF THE LANDS AND ARE ESTABLISHED AND AGREED UPON FOR THE PURPOSE OF ENHANCING AND PROTECTING THE VALUE, DESIRABLILITY, AND ATTRACTIVENESS OF THE LANDS AND EVERY PART THEREOF ALL OF THE LIMITATIONS, RESTRICTIONS, CONDITIONS, AND COVENANTS SHALL RUN WITH THE LAND AND SHALL BE BINDING ON ALL PARTIES HAVING OR ACQUIRING ANY RIGHT, TITLE, OR INTEREST IN THE DESCRIBED LANDS OR ANY PART THEREOF:
