(1) That it will hury sll line pipe laid upon said land to a gumfient depih so ns not to interfere with the cultivation of the soil.
(2) That it will pay to grantorl any damages which may ariso to growing cropt, trees, shruhbery, fences or buildings from the construction, maintenance or operation of said pipe lines, suid damages, if not mutually agreed upon, to be ascertained and determiced by three disinterested perzonz, one of whom shall be appointed by the grantors. nae by the grantee, and tine third to be selected by t1. 'To appointed as aforeaid, and the waitten award of such three persons shall be final, conclusive end bin ing upon the parties herelo.
(3) That grantee, upon written application by the grantore-; will make, or cause to be sade, a tap in any gas pipe line constructed by graytee upon the above described previses for the purpose of supplying gas to grantore, for domestic purposes only and not for resile, and for use upon the above deseribed fremises only. All connections required, shall be fumisked and paid for by Grantor with the exception of the meter, which is to be furnished and owned by the Grantee. Said tap, rill be provided by grantee from a convenient point on its main line or some lateral as the grantee may determine, and gan to be taken under this provisics shall be measured and furnished to the grantor ${ }^{\text {t }}$ at the rates eisd upon the terms as may be etahlished by grantee, or by any vendee of grantec, from time to time.
(4) That grantee will replace or tebuild to the satiffiction of grantorg or of thele representative any and all damaged parts of all drainage Eystems, the damsige to which shall be occasioned by the construction of said pipe lines under and through the above dencribed premites.
This histiument, and the covenants and agresments berein consained, whall inure to the berefit of and be binding and obligaicry upon the heirs, executors, administratons siccescors and assigns of the respentive partics.
