## DEED OF DISTRIBUTION BY PERSONAL REPRESENTATIVE

East thirty (30) acres of the Southeast Quarter (SE1/4) of the Southwest Quarter (SW 1/4) of Section Ten (10), Township fifteen (15) North, Range Ten (10) East of the 6th P.M., less approximately three (3) acres taken for levee right of way, Douglas County, Nebraska.
