



## DEDICATION

KNOW ALL MEN BY THESE PRESENTS: That GIFFORD HOMES, INC., being the owner of a part of the North 1/2 of the Northeast 1/4 of Section 13, T.17 N., R.8 E. of the 6th P.M. described as follows: Commencing at a point on the south margin of said north 1/2, 777.8 feet east of its southwest corner; thence east along its south margin 278 feet; thence north, parallel with its west margin 175 feet; thence east, parallel with its south margin 114 feet; thence north, parallel with its west margin 539.55 feet; thence west, parallel with its south margin 114 feet, thence north, parallel with its west margin 160 feet; thence west, parallel with its south margin 278 feet; thence south, parallel with its west margin 160 feet; thence east, parallel with its south margin 114 feet; thence south, parallel with its west margin 539.55 feet; thence west, parallel with its south margin 114 feet; thence south to the point of beginning, do hereby subdivide and plat said tract as HOWARD WILLIAMS SECOND ADDITION to Fremont, Nebraska. Said Addition consists of 4 blocks, numbered 5, 6, 7 and 8. Said blocks are subdivided into lots with their number and dimensions shown on this plat.

We dedicate for perpetual use by the public, 20 TH STREET, 22 ND STREET and HOWARD STREET which are 50 feet in width.

We here grant to the City of Fremont, and any public or private utility company and for reciprocal use by abutting property owners, an easement across the west 5 feet of Lot 1, Block 5; across the south 30 feet of all Lots in Block 5; and across the rear 10 feet of all other Lots in this addition for the sole purpose of construction and maintenance of utility lines and pipes.

By affixing our signatures hereto, we acknowledge this dedication and plotting to be our voluntary act and deed.
