

- 1. Assignor hereby assigns to Assignee all of its rights, obligations and duties as Declarant under the Declaration.
- 2. Assignee hereby assumes all of Assignor's rights, obligations and duties as Declarant under the Declaration.
- 3. Accordingly, for all purposes, Assignee is hereby the Declarant under the Declaration effective immediately.
- 4. This Assignment and Assumption of Declarant Rights shall be indexed and recorded against all of the following legally described property:
- Lots 1, 3 through 6, inclusive, and 9 through 47, inclusive, all in Indian Creek, a subdivision as surveyed, platted and recorded in Douglas County, Nebraska, and $\mathcal{OC}_{-1:X}$

Lots 1 through 8, inclusive, Indian Creek 2nd Addition, a subdivision as surveyed, platted and recorded in Douglas County, Nebraska.
