




CONSENT AND RATIFICATION OF PLAT

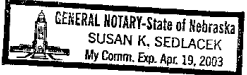

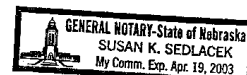

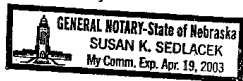
