

I hereby certify as follows:

That I have accurately surveyed and staked with iron pipe the lats and streets in Kimberly Place as shown on this plat, also an iron pipe at all points marked thus o on the plat.

That Kimberly Place is located in the NE% of the SW% of section 9, T.I.5 N., R.12 E. of the 6th P.M., Douglas County, Nebraska, and more particularly described as follows: - Beginning at the S.E. corner of the NE'4 of the SW'4 of said section 9; thence \$89°53'W a distance of 825.0 feet; thence N.8°47'E. a distance of 273.8' feet; thence N.8°23'IV. a distance of 192.1 feet; thence N.26°53'W. a distance of 480.0 feet; thence N. 63'07' E. a distance of 190.0 feet to the point of beginning of a curve having a central angle of 64° and a radius of 267.10 feet; thence northerly along said curve a chord distance of 85.0 feet, said chard bearing N. 36°02'W; thence N. 56°28'E. a distance of 110.0 feet; thence N. 24°33'E. a distance of 824 feet; thence N. 79°03' E. a distance of 89.8 feet; thence N. 26° 28' E. a distance of 149.0 feet to a point on a curve having a central angle of 29°50' and a radius of 401.4 feet; thence southeastern along said curve a chord distance of 145.4 feet, to end of said curve, said chord bearing \$ 550 17 E, thence S. 45° 48' E. a distance of 1.75.0 feet to the point of beginning of a curve having a central angle of 45 and a radius of 218.14 feet; thence southeasterly along said curve a chord distance of 165.8 feet, said chord bearing S.68° 18'E; thence N. 89° 50' E. a distance of 220.0 feet; thence due south along & Section Line and centerline of 102 nd Street a distance of 1050.0 feet to point of beginning

( For the purpose of this description, the centerline of 102 nd Street is considered to be due north

and south.)
