KNOW ALL MEN BY THESE PRESENTS:

THAT Joseph E. Mestecky and Ruth Elaine Mestecky, Husband and Wife

of the County of Douglas and State of Nebraska for and in consideration of the sum of - - Sixteen Thousand Twenty-Five and no/100- - - - (\$16,025.00) - - - DOLLARS

in hand paid do hereby grant, bargain, sell, convey and confirm unto THE STATE OF NEBRASKA the following described real estate situated in Douglas County, and State of Nebraska, to-wit:

A tract of land located in the Southeast Corner of the Northwest Quarter of the Southeast Quarter of Section 23; Township 16 North, Range 12 East of the 3rd P.M., Douglas County, Nebraska, described as follows:

Beginning at the East Quarter Quarter Corner of the Southeast Quarter of said Section 23; thence westerly on the South Line of the Northwest Quarter of the Southeast Quarter of said Section 23 a distance of 1,170.7 feet; thence northeasterly 157 degrees 12 minutes right a distance of 571.2 feet; thence continuing northeasterly on a 2,181.83 foot radius curve to the left (initial tangent of which forms an angle of 04 degrees 00 minutes right from the last described course) a distance of 730.9 feet to a point on the East Line of said Northwest Quarter of the Southeast Quarter; thence southerly on said East Line a distance of 568.6 feet to the point of beginning, containing 6.83 acres, more or less, which includes 0.42 acre, more or less, previously occupied as a public highway, the remaining 6.41 acres, more or less, being the additional acreage hereby secured.

That portion of the above described tract lying southeasterly from the following described Controlled Access line shall be part of a Controlled Access facility as defined in Section 39-1302 (6) R. R. S., 1943, and the remainder of said Northwest Quarter of the Southeast Quarter which by the reason of the taking herein described now abuts on a highway where none existed theretofore is subject to the provisions of Section 39-1329 R. R. S., 1943.

Referring to the East Quarter Quarter Corner of the Southeast Quarter of Section 23; thence westerly on the South Line of the Northwest Quarter of the Southeast Quarter of Section 23 a distance of 885.3 feet to the point of beginning of said Controlled Access Line; thence northeasterly 161 degrees 12 minutes right a distance of 302.7 feet to point of curvature; thence continuing northeasterly on a 2,313.83 foot radius curve to the left (initial tangent of which coincides with the last described course) a distance of 674.2 feet to the point of termination of said Controlled Access Line, said point being on the East Line of said Northwest Quarter of the Southeast Quarter.

TO HAVE AND TO HOLD the premises above described, together with all the Tenements, Hereditaments and Appurtenances thereto belonging, unto the said The State of Nebraska and to its successors and assigns forever.

And I do hereby covenant with the said Grantee and with its successors and assigns that I am

fully seized of said premises; that they are free from encumbrance

that I have good right and lawful authority to sell the same; and I do hereby covenant to warrant and defend the title to said premises against the lawful claims of all persons whomsoever.


