ASSIGNMENT OF AUTHORITY TO APPOINT THE ARCHITECTURAL CONTROL COMMITTEE UNDER THE DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS FOR LAKE RIDGE ESTATES
