



KNOW ALL MEN BY THESE PRESENTS: THAT WE, DODGE-LOTS JOINT VENTURE, A NEBRASKA JOINT VENTURE, LOTS, INC., A NEBRASKA CORPORATION AND DODGE LAND CO., A NEBRASKA CORPORATION, OWNERS OF THE LAND DESCRIBED WITHIN THE SURVEYOR'S CERTIFICATE AND EMBRACED WITHIN THIS PLAT, HAVE CAUSED SAID LAND TO BE SUBDIVIDED INTO LOTS TO BE NUMBERED AS SHOWN, SAID SUBDIVISION TO BE HEREAFTER KNOWN AS LAKEWOOD VILLAGES REPLAT 15, AND WE DO HEREBY RATIFY AND APPROVE OF THE DISPOSITION OF OUR PROPERTY AS SHOWN ON THIS PLAT. 
