## WHOM IT MAY CONCERN:

Notice is hereby given that Metropolitan Utilities District has, under its construction order procedure, installed a gas main, in the following streets:

Between Hartman Avenue and Parkview Lane and from 63rd Street to 66th Street,

in Omaha, Douglas County, Nebraska, or adjoining said city, abutting the lots or parcels of land described below: Lots 9, 10, 11, 12, 13, 15, 17 and 18, Block 1; Lots 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, 13, 14, 15, 16, 17, 18, 19 and 20, Block 2; Lots 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, 13, 14, 15, 16, 17, 18, 19, 20, 21 and 22, Block 3; Lots 1, 2, 3, 5, 6, 7, 8, 9, 10, 12, 13, 14, 15, 16, 17, 18, 19, 20, 21, 22 and 23, Block 4; Lots 13, 14, 15 and 24, Block 5; Lots 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, 13, 14, 15, 16, 17, 18, 19, 20, 21, 22, 23 and 24, Block 8; Lots 1, 2, 3, 4, 5, 6 and 7, Block 9; Lamp's Benson Addition East 88 feet of the south 627 feet more or less of the north 660 feet more or less in the SE $\frac{1}{4}$  of the SW $\frac{1}{4}$  of Section 36-16-12 east South 88 feet, except street, of the east 213.2 feet of the west 662 feet in the NW $\frac{1}{4}$  of the SE $\frac{1}{4}$  of Section 36-16-12 east Lot 1, Block 5, Lamp's Benson Addition

A connection charge of \$ 1.38 per foot will be made as to each of said lots or parcels of land whose owners apply for, and receive, service from such main. This charge is in lieu of an assessment which would have been made if said main had been installed under the statutory procedure for main extensions. The connection charge may be paid in full, or in installments, as provided by the Rules and Regulations of Metropolitan Utilities District.

When the connection charge has been paid in full by the owner of a lot, a receipt will be issued and may be recorded by him. Inquiry may be made of the New "Services" Section of Metropolitan Utilities District as to whether a connection to said main has been made as to any one of the lots or parcels of land hereinabove described, and the amount of the connection charge remaining unpaid, if any.
