The undersigned grantor hereby grants to said City, its successors and assigns the right, privilege and authority to enter upon and pass over said property and the property of the grantor adjacent thereto for the purpose of surveying, constructing, repairing, operating, and maintaining said lines and equipment including the right and authority to cut down or triw any trees or limbs of trees on either side thereof which might be a hazard to said transmission lines.
