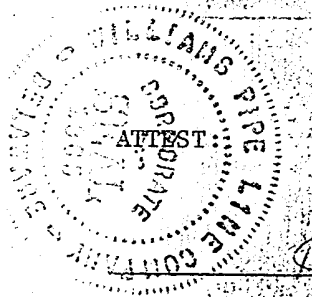
AGREEMENT

KNOW ALL MEN BY THESE PRESENTS that WILLIAMS ~~PIPE LINE~~ PIPE LINE COMPANY, for and in consideration of One Dollar (\$1.00) and the promises herein contained, hereby grants permission to NORTHWESTERN BELL TELEPHONE COMPANY for the installation of buried telephone cables across Williams ~~PIPE LINE~~ Pipe Line Company's easement in Leawood Oaks, a subdivision of the N $\frac{1}{2}$  NW $\frac{1}{4}$  of Section 9-13N-13E, according to the recorded plat thereof, Sarpy County, Nebraska, at locations parallel and about two (2) feet north of the south lines of Lots 69, 70, 187, 191, 150, 151, 130 and 131, and also parallel and about two (2) feet south of the north lines of Lots 16 and 17 of said Leawood Oaks. The telephone cables are to be constructed a minimum of twelve (12) inches below the bottom of Williams ~~PIPE LINE~~ Pipe Line Company's deepest pipe line. Northwestern Bell Telephone Company agrees that it shall notify Williams ~~PIPE LINE~~ Pipe Line Company no less than forty-eight (48) hours before work begins on the pipe line easement.

Northwestern Bell Telephone Company shall assume, indemnify and save harmless Williams ~~PIPE LINE~~ Pipe Line Company from all cost, loss, damage, expense or claim of any nature arising from the installation or existence of the telephone cables herein permitted.

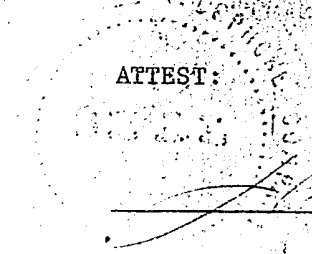


