CERTIFICATE

TO: THE COUNTY CLERK OF SARPY COUNTY, NEBRASKA and THE TREASURER OF SARPY COUNTY, NEBRASKA

I, THE UNDERSIGNED, KRISTY J. GREGATH, hereby certify that I am the Clerk of Sanitary and Improvement District No. 180 of Sarpy County, Nebraska, and that at a meeting of the Board of Trustees of said District, duly called and held on July 26, 2000, a quorum being present, the following resolution was unanimously adopted by the Board of Trustees, to-wit:

WHEREAS, the Board of Trustees of Sanitary and Improvement District No. 180 of Sarpy County, Nebraska, did sit as a Board of Adjustment and Equalization on July 26, 2000, having duly complied with all statutory requirements with respect to notices pertaining to such special assessments proposed to be levied in Lakewood Villages, Lots 1, 2, 3, 4, 5A, 5B, 6A, 6B, 7A, 7B, 8A, 8B, 9A 9B, 10A, 10B, 11A, 11B, 12A, 12B, 13A, 13B, 14A, 14B, 15A, 15B, 16A, 16B, 17A, 17B, 18A, 18B, 19A, 19B, 20A, 20B, 21A, 21B, 22A, 22B, 23A, 23B, 24A, 24B, 25A, 25B, 26A, 26B, 27A, 27B, 28A, 28B, 29A, 29A, 30A, 30B, 31A, 31B, 32A, 32B, 33A, 33B, 34A, 34B, 35A, 35B, 36A, 36B, 37A, 37B, 38A, 38B, 39A, 39B, 40A, 40B, 41A, 41B, 42A, 42B, 43A, 43B, 44A, 44B, 45A, 45B, 46A, 46B, 47A, 47B, 48A, 48B, 49A, 49B, and Lots 50 through 179, all a part of the subdivision located within the District for the following identified public improvements constructed therein by the District, to-wit: Sanitary Sewer, Section I; Interlocal Agreement with SID No. 85; Storm Sewer, Section I, Paving, Section I; Underground Power, Section I; and Water, Section I.

WHEREAS, said Board of Trustees at said meeting duly considered all objections thereto.

NOW, THEREFORE, BE IT RESOLVED, that the Board of Trustees of Sanitary and Improvement District No. 180 of Sarpy County, Nebraska, find and determine:

1. That the lots or parcels of land in Lakewood Villages, Lots 1, 2, 3, 4, 5A, 5B, 6A, 6B, 7A, 7B, 8A, 8B, 9A 9B, 10A, 10B, 11A, 11B, 12A, 12B, 13A, 13B, 14A, 14B, 15A, 15B, 16A, 16B, 17A, 17B, 18A, 18B, 19A, 19B, 20A, 20B, 21A, 21B, 22A, 22B, 23A, 23B, 24A, 24B, 25A, 25B, 26A, 26B, 27A, 27B, 28A, 28B, 29A, 29A, 30A, 30B, 31A, 31B, 32A, 32B, 33A, 33B, 34A, 34B, 35A, 35B, 36A, 36B, 37A, 37B, 38A, 38B, 39A, 39B, 40A, 40B, 41A, 41B, 42A, 42B, 43A, 43B, 44A, 44B, 45A, 45B, 46A, 46B, 47A, 47B, 48A, 48B, 49A, 49B, and Lots 50 through 179 in Lakewood Villages, a subdivision as surveyed, platted and recorded in Sarpy County, Nebraska, all located within the District, identified on the schedule attached hereto, were specifically

benefitted in the amounts shown opposite each lot or tract of property as shown on said schedule, and the amount of said benefit does not exceed the costs of such portion of the construction of said improvements as are local improvements, and the amount set opposite each lot and tract of said schedule is an equitable apportionment of the cost of the local improvements between the several lots and tracts in proportion to the special benefits received by each lot or tract and does not exceed said special benefits.

2. That each of the lots or tracts of land identified on said attached schedule shall be specially assessed in the amount shown opposite each lot number or tract number on said schedule of special assessments.

3. That the undersigned further certifies that said special assessments may be paid without interest within fifty (50) days from and after July 26, 2000, to-wit: September 13, 2000, and if not so paid, the assessments shall become delinquent in ten (10) equal installments as follows:

1/10 on July 26, 2001
1/10 on July 26, 2002
1/10 on July 26, 2003
1/10 on July 26, 2004
1/10 on July 26, 2005
1/10 on July 26, 2006
1/10 on July 26, 2007
1/10 on July 26, 2008
1/10 on July 26, 2009
1/10 on July 26, 2010

Each installment shall bear interest at the rate of eight percent (8%) per annum after July 26, 2000, until delinquent and at ten percent (10%) per annum thereafter until paid.

Said assessments shall be duly spread upon the tax records of Sarpy County, Nebraska, and collected by the County Treasurer of Sarpy County, Nebraska, as provided by law.

BE IT FURTHER RESOLVED, that the said special assessments are hereby levied upon several lots or tracts of ground in accordance with the attached schedule of special assessments.

BE IT FURTHER RESOLVED, that the Clerk of the District be and hereby is directed to certify to the County Treasurer of Sarpy County, Nebraska
